Applications for Primary and Secondary places

If your child is due to start primary school in September 2026, you will need to apply for a place. Even if your child is in a school nursery, you need to apply for a reception place. You need to complete the online application at

https://durham.gov.uk/schooladmissions. If you don't live in Durham, you will need to make your application to the LA where you pay your council tax. The closing date for all applications is 15 January 2026. You are advised to list at least three school preferences on your application. It is very important that if you want your child to attend Westlea that you put us down as first choice.

Secondary school applications: If your child is due to start secondary school in September 2026, you need to complete the online application at

https://durham.gov.uk/schooladmissions If you don't live in Durham you will need to make your application to the LA where you pay your council tax. The closing date for all applications is 31 October 2025.. There is no guarantee you will get your first choice.

This week 4 classes reached 96% or above.




Sometimes it's quiet actions that can make the most difference...

Consultation letter 1st Oct – 26TH Nov



Please see a consultation letter regarding reducing our PAN (Pupil Admissions Number), from 38 to 30, in school. This will take effect from September 2027. Any existing classes over this number are not affected by these changes but moving forward the change in this number should have a positive benefit to the children, staff and wider community in school.

The school will also be capping our other classes Y1-Y6 to a maximum of 30 however, existing pupils in school are not affected by this.

Congratulations Rev Anita!



Head Teachers Chat




Every week, each class has a Star of the Week award that is presented in Celebration assembly. Pupils from Y1- Y6, who are recognised for this, are then asked to come along during the week for a Hot Chocolate and a pupil discussion with Mrs Scothern.

During this time, Mrs Scothern asks questions surrounding many topics in school. These discussions will range from how to keep safe, what do we mean by bullying, pupils learning experiences, homework, how do teachers help you, what are the school lunches like... the list goes on. The pupils who attend the discussions are always respectful of each other's opinions and listen carefully. Mrs Scothern takes notes and feeds these responses back to staff and Senior leaders in school.

In other news...

Safeguarding – Martyn's Law



The act which became law in April 2025 aims to help schools to minimise the impact of a terrorist attack. Its purpose is to improve protective security and organisational preparedness across the UK.

Terrorists have targeted a wide range of people and places in recent years. It is not always possible to predict where in the UK an attack might happen, or the type of premises or events that could be impacted – either directly (as the target of an attack) or indirectly (by being located near to the target of an attack). The threat level from terrorism in the UK is currently substantial, meaning an attack is likely. That is why having effective procedures in place is important.

The Department for Education (DfE) have supported the introduction of the act. They have worked with the Home Office to set out the policy for education settings.

All schools will need to have appropriate procedures in place. This includes:

- evacuation (to get people out of the building)
- invacuation (moving people to a safe place)
- lockdown (to secure the premises against attackers)
- communication


There is no requirement to put physical security measures in place.

These procedures will be developed across the next two years. The government will publish statutory guidance during this period. This guidance will assist schools to understand the requirements set out in the legislation and keep parents informed.

Sticks are among nature's most basic things, yet they offer endless opportunities for creative and adventurous play. Children naturally gravitate towards sticks, drawn by their texture, shape, and sheer potential. When kids play with sticks, they're not just entertaining themselves; they're engaging in a form of play that promotes physical activity, creativity, and cognitive development.

Every week, the pupils spend a full session down in the woods and explore the environment, learning through play, whilst learning, taking risks and keeping safe.

What Parents & Educators Need to Know about

TIKTOK

WHAT ARE THE RISKS?

Adults tend to associate online videos with YouTube – but among teens, TikTok is king. The app provides a stream of short clips tailored to users' interests, based on what they've already watched. Around half of British children use TikTok, and while much of the content is benign, Ofcom considers it the app where youngsters "were most likely to encounter a potential harm".

AGE-INAPPROPRIATE CONTENT

While TikTok's Following feed only displays videos from familliar creators, for You Is a collection based on a user's previously watched clips. Most of these videos will probably be inoffensive, but the app could potentially show something unsuitable. If children then engage with this content, more like it will follow. TikTok's guidelines prohibit the sharing of illegal or inappropriate content, but the huge number of uploads means that a small amount inevitably silos through.

BODY IMAGE AND DANGEROUS CHALLENGES

According to Ofcom, most online harms for teens are body image related for girls (promoting unhealthy eating, body shaming and so on) and dangerous stunts for boys. Both are prevalent on TikTok. One extreme example of the latter was the 'blackout' trond, which encouraged users to hold their breath until they passed out from a lack of oxygen. This led to two families fliing lawsuits against TikTok over the tragic deaths of their children.

IN-APP SPENDING

TikTok is free, but users have the option to buy likTok coins, which can be used to purchase glifts for content creators. Coin bundles range from £9.99 to an eye-watering £93; while that may not sound appealing, the app still generated £7.9 billion in user spending in 2023. TikTok's policy is that under-18s can't make in-app purchases, but it's possible to bypass this with a fake birth date.

CONTACT WITH STRANGERS

With more than 1.5 billion users globally, the potential for contact from strangers on TikTok is high – especially as accounts created by over-lies (or young people using a fake date of birth) are set to public by default. This means that not only is someone's profile visible to everyone else on the app, it also suggests their videos to others and enables anyone to download or comment on them.

MISINFORMATION AND

Although the short videos on TikTok tend to be more frivolous than the longer ones on YouTube, clips can still influence impressionable minds in a negative way. Not only is there plenty of dangerous misinformation on TikTok. Jud Videom reports that nearly a third of 12 to 15-year-olds use TikTok as a news source – so you should be wary of misogynistic, racist or conspiracy-themed material shaping how they see the world.

ADDICTIVE DESIGN

With its constant stream of eye-catching videos, TikTok can be addictive to young brains. In 2024, UK children spent an average of 127 minutes per day on the app: that's twice as much as in 2020. Excessive use can interfere with young people's sleep patterns – often leading to irritability – and distract them from other, healthier activities. The instantly skippable nature of bite-size videos may also

Advice for Parents & Educators

ENABLE FAMILY PAIRING

Family Pairing allows parents to link their Tikrok account to their child's, and control settings remotely. Parents can then turn on Restricted Mode (reducing the chances of a child seeing inappropriate content), set screen-time limits, make accounts private and manage whether their child can send messages — and if they can, to whom. Children can't alter these settings without parental approval.

DISCUSS THE DANGERS

If a child wants to use TikTok and you're happy for them to do so, it's good practice to discuss the potential risks. Ensure that they don't share any identifying personal information, and that they know to talk to a trusted adult if they're worried by interactions on the app. With more teens using TikTok for news, it's also worth talking about misinformation and propaganda, and how to identify it.

BLOCK IN-APP SPENDING

If a child is using an irrone of Anaroia device of access it (ok, you can alter their settings to prevent them from making in-app purchases. We'd recommend enabling this feature, as it can be quite easy for a young person to spend a significant amount of real money buying TikTok coins to unlock more features of the app – sometimes without even realising.

READ THE SIGNS

If you're concerned that a child is spending too much time on TikTok, or that they've been emotionally affected by something they've sean, it's important to know how to spot the signs. Increased irritability and a lack of concentration are potential red flags, as is failing to complete homework or skipping meals. Remember, the parential controls are there for a reason, and it's never too late to introduce limits.
