

## Equality Information and Equality Objectives for Westlea Primary School

### Equality Act 2010 Westlea Primary Schools' provision of the public sector equality duty

**Date: December 2025**

We in Westlea Primary School are committed to equality. We aim for every pupil to fulfil their potential no matter what their background or personal circumstances.

We maintain the aim of embedding principles of fairness and equality across our entire curriculum, in assemblies and acts of collective worship, in break and lunchtimes, in pastoral support and in before and after school activities and school trips and residential.

We must under the general duty of public sector equality duty, in the exercise of our functions, have due regard to the need to:

- ✓ Eliminate discrimination, harassment, victimisation and any other conduct that is prohibited under the Act.
- ✓ Advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it;
- ✓ Foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

This will apply to all pupils, staff and others using the facilities. We will give relevant and proportionate consideration to the public sector equality duty.

The protected characteristics for the schools provisions are:

- Disability
- Gender Reassignment (Gender Identity)
- Pregnancy and Maternity
- Race (Ethnicity)
- Religion or Belief
- Sex
- Sexual Orientation
- Age (only applicable to staff, not pupils)
- Marriage and Civil Partnerships (only applicable to staff, not pupils)

Age and marriage and civil partnership are NOT protected characteristics for the schools provisions for pupils.

We will have **due regard** to advancing equality of opportunity including making serious consideration of the need to

- remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic;
- take steps to meet the needs of persons who share a protected characteristic that are different from the needs of persons who do not share it;
- encourage persons who share a relevant protected characteristic to participate in public life or in any activity in which participation by such persons is disproportionately low.

We will take into account the six Brown principles of ‘due regard’

- **awareness** – all staff know and understand what the law requires
- **timeliness** – implications considered before they are implemented
- **rigour** – open-minded and rigorous analysis, including parent/pupil voice
- **non-delegation** – the PSED cannot be delegated
- **continuous** – ongoing all academic year
- **record-keeping** – keep notes and records of decisions & meetings

We welcome the opportunity to be transparent and accountable. To this end we fulfil the specific duties of the Act by:

- ✓ publishing our equality information
- ✓ publishing our equality objectives

We aim to make the information accessible, easy to read and easy to find.

**Pupil Equality Profile:**

Age	We have pupils aged from 3 to 11 years old in our school.
Disability - A person is disabled under the Equality Act 2010 definition if they have a physical or mental impairment that has a ‘substantial’ and ‘long-term’ negative effect on their ability to do normal daily activities.	100% pupils gave information. 5% of pupils recorded a disability. We ensure reasonable adjustments are made where appropriate.
EAL (English as an Additional Language)	6% EAL The languages spoken within our pupil profile are: English, Polish, Greek, Fijian, Spanish, Persian/Farsi and Romanian
Gender Reassignment (Gender Identity)	We are an inclusive school community and support any pupil exploring their gender identity.
Pupil Premium <i>(Although this isn’t a protected characteristic under the Equality Act, our school feel it is an important aspect of our school profile)</i>	54% pupils eligible for Pupil Premium

Race (Ethnicity)	94% of pupils White British 3% other black Less than 1% other Less than 1% mixed 1% other white
Religion and Belief	100% pupils gave information Our pupil profile comprises: Christian, Muslim, No religion
SEND	30% pupils identified by school with a Special Educational Need 86% SEND Support Plan 14% Education Health and Care Plan (EHCP)
Sex (Gender)	100% pupils gave information 52% female 48% male
Sexual Orientation	Our school community is inclusive of all pupils regardless of their sexual orientation.

**We will update our equality information at least annually and publish on the school website. This information is used to help inform our equality objectives.**

### **Equality Objectives 2025 – 2028**

Our equality objectives are:

1. To ensure full accessibility to the curriculum and all school provision for all pupils in school.
2. To continue to promote and provide a fully inclusive school environment.
3. To ensure all pupils have access to school clubs.
